Ageism is in many ways the other "ism" that we often forget about, yet subtlety, find ourselves perpetuating. Negative attitudes toward aging have been deep seeded into our global history. Dr. Robert N. Butler was the first to coin the term ageism to speak to the negative attitudes on aging. This workshop will dissect ageism and the subtle forms that we often see in our profession.
