If you are not a professional with a private practice or in mental health you may often find yourself in need of a DSM-5 tune-up. Perhaps you are in private practice or the mental health field and just need a refresher. We will go back to the basics and review some of the major content areas and psychiatric disorders. This may be even more applicable if you are in the healthcare arena where you are often faced with patients that may have mental health disorders that can exacerbate coping with their physical problems as well. We will be focusing on some of the major content areas of the DSM-5. We will review common disorders, the criteria for diagnosing and breaking it down. In addition, we will be reviewing some ethical frameworks for social work, case management, nursing, and counseling. We will begin our day of learning going through some of the various disorders through interactive discussions around case scenarios and ethics. This training will enhance your knowledge of the disorders, criteria, and chapters of the DSM-5 while providing ethical discussions at the same time.

BY THE END OF THE SESSION, THE PARTICIPANT WILL BE ABLE TO:

1. Identify three different ethical standards around the DSM-5 relating to diagnosis
2. Name at least five psychiatric disorders within the DSM-5 and three of their criteria
3. Recall at least four anxiety disorders
4. Identify three neurocognitive disorders
5. Examine case examples and ethical discussion on the DSM-5 disorders and diagnosis
