In the first half of this presentation, learn about the Artist-in-Residence program, an innovative intergenerational living initiative where music students live alongside older adults in an assisted living facility, fostering deep connections through creative engagement.

In the second half, we'll delve into practical arts-based approaches—ranging from group singing and letter writing to the use of commonplace books and animatronics—that support dementia caregivers in enhancing communication and emotional well-being. This session offers practical, therapeutic tools that bridge generations and empower caregivers through the healing power of the arts.

BY THE END OF THIS SESSION, THE PARTICIPANT WILL BE ABLE TO:

- 1. Examine the impact of intergenerational engagement through the Artist-in-Residence program, highlighting how music fosters relationships between students and older adults in an assisted living environment.
- 2. Demonstrate the application of various arts and humanities—including group singing, commonplace books, animatronics, and letter writing—specifically for enhancing the well-being of dementia caregivers and their loved ones.
- 3. Summarize the therapeutic benefits of creative expression in promoting mental, emotional, and social health in aging populations and their caregivers, emphasizing practical techniques that can be used by healthcare professionals and caregivers alike.
